Workshop Dates:

November 9-10, 2004 (Tuesday and Wednesday)

Location:

CH2M HILL Alumni Center at Oregon State University in Corvallis

Workshop Fee:

The \$135 fee for the two-day workshop includes a course notebook, break refreshments and lunches.

Continuing Education Credits:

Lodging:

A limited block of rooms has been reserved at the new Hilton Garden Inn, 541-752-5000. The Hilton is located one block from the CH2MHill Alumni Center at the intersection of SW 26th and SW Western Blvd. To guarantee the \$79 OSU rate make your reservation by October 8th and mention you are with the iSNAP Workshop. Directions:

If you are traveling on Interstate 5, take the Highway 34 exit which reads "Corvallis / Oregon State University" (exit 228). Go west on Highway 34 for about 10 miles to Corvallis. Follow the Highway 34 signs making a left just before you enter Corvallis. Then follow the signs to the OSU and take a right on SW 26th St and the center is on your right after crossing Washington Way. The CH2M HILL Alumni Center is across from Reser Stadium.

Parking:

Daily parking permits cost \$5 per day and can be purchased with cash or credit card at two locations in the Reser Stadium parking lot for parking in use any visitor or student lot. Parking should be available in the stadium lot or the gravel lot east of the Hilton near the baseball field.
